C. PRESIDENT'S REPORT:

Dr. Chrisagis welcomed Assistant Attorney General Michael Raine and thanked him for filling in for Ms. Baskin.

D. REVIEW, DISCUSSION AND POSSIBLE ACTION ON INVESTIGATIVE REVIEWS/COMPLAINTS:

1. Helen Paulin, O.D. IR#201715

Dr. Peller summarized the case as 1-800 Contacts alleges that Dr. Paulin did not respond to a request for a copy of a prescription. There were 45 complaints for 33 patients; 3 of the patients were never seen by Dr. Paulin, 6 patients' records were in storage, 7 prescriptions were expired, 1 there was no contact lens exam so there was no prescription. Fourteen (14) prescriptions were valid however only one response was sent back to 1-800 Contacts by Dr. Paulin.

Keith Call, attorney for 1-800 Contacts was present to address the Board stating that Dr. Paulin's address and fax number were verified and that the evidence is clear that Dr. Paulin did not respond to requests.

- **MOTION:** Dr. Mach moved to issue a Letter of Concern for violation of the Fairness to Contact Lens Consumers Act for not responding to a medical records request. Dr. Peller seconded the motion.
- **VOTE:** Motion passed 5-1. Dr. Husz voted no.
- 2. Larry Allgood, O.D. IR#201735

Dr. Mach summarized the case as 1-800-Contacts alleges that Dr. Allgood did not respond to a request for copy of a prescription. There were 23 complaints for 14 patients. Dr. Allgood's response to the Board is incomplete at this time and the Board is unable to determine if Dr. Allgood responded to the prescription requests from 1-800 Contacts.

- **MOTION:** Dr. Mach moved to go to Informal Interview pursuant to §32-1743 for failure to properly respond to the complaint pursuant to A.R.S. §32-1744(C) and for recordkeeping pursuant to A.A.C. R4-21-305. Dr. Peller seconded the motion.
- **VOTE:** Motion passed 6-0
- 3. Erika Wilken, O.D. IR#2017194

Dr. Peller summarized the case as 1-800-Contacts alleges that Dr. Wilken failed to respond to a request for a copy of a prescription. There were 36 complaints for 13 patients; Dr. Wilken stated in her response that no requests were received from 1-800 Contacts for any of the of the patients.

Keith Call, attorney for 1-800 Contacts was present to address the Board stating that this is about a request for copy of a prescription versus just the verification of it and that he has copies of the requests sent to Dr. Wilken; the fax numbers are correct. He stated that the period of violation was August 1, 2014 through September 3, 2015 and that on December 4, 2017, the fax numbers were verified again by 1-800 Contacts as valid fax numbers.

- **MOTION:** Dr. Mach moved to issue a Letter of Concern for violation of the Fairness to Contact Lens Consumers Act for not responding to a medical records request. Dr. Peller seconded the motion.
- **VOTE:** Motion passed 6-0.
- 4. Ricci Rios, O.D. IR#2017222

Dr. Peller summarized the case as 1-800-Contacts alleges that Dr. Rios failed to provide a copy of a prescription when requested. There were 66 complaints for 26 patients; 5 requests were for expired prescriptions, 16 patients there were no requests for a copy of a prescription, 2 patients were not patients of Dr. Rios.

Keith Call, attorney for 1-800 Contacts was present to address the Board stating there were 66 violations and no responses were sent for any. He stated that the fact that the prescription is expired or not the doctor's patient is not an excuse for failure to comply with the FCLCA and patient protection demands compliance. Mr. Call stated that if the most significant violators are warned, the word will get out that all doctors need to comply with the law.

- **MOTION:** Dr. Mach moved to issue a Letter of Concern for violation of the Fairness to Contact Lens Consumers Act for not responding to a medical records request. Dr. Peller seconded the motion.
- **VOTE:** Motion passed 5-0. Dr. Lamb recused from the discussion and vote.
- 5. David Anderson, O.D. IR#2017223

Dr. Mach summarized the case as 1-800-Contacts alleges that Dr. Anderson failed to release a copy of a prescription when requested. There were 74 completes for 34 patients. Dr. Anderson submitted no response or narrative, only incomplete medical records.

- **MOTION:** Dr. Mach moved to go to Informal Interview pursuant to A.R.S. §32-1743 for failure to properly respond to the complaint pursuant to A.R.S. §32-1744(C) and for recordkeeping pursuant to A.A.C. pursuant to §32-1743 for failure to properly respond to the complaint pursuant to A.R.S. §32-1744(C) and for recordkeeping pursuant to A.A.C. R4-21-305. Dr. Peller seconded the motion.
- **VOTE:** Motion passed 6-0.

6. Jeffrey Girardin, O.D. IR#201891

Dr. Peller summarized the case as 1-800-Contacts alleges Dr. Girardin failed to release a copy of a contact lens prescription when requested. There were 13 patients, none for which a request was received from 1-800 Contacts.

Keith Call, attorney for 1-800 Contacts was present and addressed the Board stating that the fax numbers and the addresses are correct and that the Board needs to discipline the doctor based on the preponderance of evidence.

- **MOTION:** Dr. Peller moved to dismiss the case due to lack of violation of the optometric practice act. Dr. Husz seconded the motion.
- **VOTE:** Motion passed 4-2. Drs. Chrisagis and Mach voted no.
- 7. Sherri Horwitz, O.D. IR#201892

Dr. Peller summarized the case as 1-800-Contacts alleges that Dr. Horwitz did not respond to a request for copy of a prescription. There were 31 complaints for 21 patients. There appeared to be a lack of response by Dr. Horwitz as no narrative or medical records were submitted, only a brief statement.

MOTION: Dr. Mach moved to issue a Letter of Concern for violation of the Fairness to Contact Lens Consumers Act.

The motion died for lack of a second.

- **MOTION:** Dr. Chrisagis moved to go to Informal Interview pursuant to A.R.S. §32-1743 for failure to properly respond to the complaint pursuant to A.R.S. §32-1744(C). Dr. Mach seconded the motion.
- **VOTE:** Motion passed 5-0. Dr. Lamb recused from the discussion and vote.
- 8. Kaci Kramer-Oldroyd, O.D. IR#201893

Dr. Peller summarized the case as 1-800-Contacts alleges that Dr. Kramer-Oldroyd failed to release a copy of a prescription when requested. There were 46 complaints for 14 patients. Dr. Peller saw no responses to the complaints in the chart and Dr. Kramer-Oldroyd did not state in her narrative whether she responded to the requests. Dr. Kramer-Oldroyd was present to address the Board stating that the fax number used by 1-800 Contacts is not a working fax number for her office as it goes to a digital folder in a main mail box at the surgical center and not to her office.

Keith Call, attorney for 1-800 Contacts was present and addressed the Board stating that the fax number is Dr. Kramer-Oldroyd's fax number and that just because it's old or ineffective does not mean she doesn't have to respond to a request sent via fax. Mr. Call when on to state that on November 10, 2016, 1-800 Contacts verified the fax number on the phone with a person in Dr. Kramer-Oldroyd's office.

- **MOTION:** Dr. Husz moved to dismiss the case due to lack of violation of the optometric practice act. Dr. Peller seconded the motion.
- **VOTE:** Motion passed 5-1. Dr. Mach voted no.
- 9. Stewart Mecom, O.D. IR#201894

Dr. Peller summarized the case as 1-800-Contacts alleges that Dr. Mecom failed to respond to a request for a copy of a prescription. There were 44 complaints for 21 patients; three of the requests were responded to by Dr. Mecom.

Keith Call, attorney for 1-800 Contacts was present to address the Board stating the date range for this complaint was July 28, 2014 through September 3, 2015. He also stated that the fax number for Dr. Mecom's office was verified by 1-800 Contacts and is a correct and valid fax number, so Dr. Mecom should have received all the requests and subsequently responded to all them.

- **MOTION:** Dr. Mach moved to issue a Letter of Concern for violation of the Fairness to Contact Lens Consumers Act for not responding to a medical records request. Dr. Peller seconded the motion.
- **VOTE:** Motion passed 5-1. Dr. Husz voted no.
- 10. Charles Roberts, O.D. IR#201895

Dr. Chrisagis summarized the as 1-800-Contacts alleges that Dr. Roberts failed to respond to a request for copy of a prescription. There were 25 complaints for 10 patients; 5 requests were responded to by Dr. Roberts, 3 were not his patients and 1, no request received. Dr. Mach stated he felt that under the FCLCA, a response is required, even if it's not the doctor's patient.

Keith Call, attorney for 1-800 Contacts was present to address the Board stating that the fax number was recently verified by 1-800 Contacts and is correct and that only 5 of the 25 requests received were responded to by Dr. Roberts. Mr. Call stated he agreed with Dr. Mach that a response should be sent back to 1-800 Contacts even if it's not the doctor's patient so that 1-800 Contacts knows there is an issue.

- **MOTION:** Dr. Peller moved to dismiss the case due to lack of violation of the optometric practice act. Dr. Lamb seconded the motion.
- **VOTE:** Motion passed 6-0.
- 11. Michael DeRubeis, O.D. IR#201896

Dr. Peller summarized the case as 1-800-Contacts alleges that Dr. DeRubeis failed to provide a copy of a prescription when requested. There were 37 complaints for 23 patients. No requests received for 18 of the patients, 4 were not his patients and one request was responded to by Dr. DeRubeis.

Keith Call, attorney for 1-800 Contacts was present to address the Board stating that once again, the Board has sworn evidence that the fax number is correct and that Dr. DeRubeis received all of the requests for copies of the prescriptions, but failed to respond to all requests. Mr. Call believes that Dr. DeRubeis has poor office management as he "doesn't buy" that 90% of the faxed requests were not received.

- **MOTION:** Dr. Mach moved to issue a Letter of Concern for violation of the Fairness to Contact Lens Consumers Act for not responding to a medical records request. Dr. Peller seconded the motion.
- **VOTE:** Motion passed 6-0.
- 12. David Rockwell, O.D. IR#201897

Dr. Peller summarized the case as 1-800-Contacts alleges that Dr. Rockwell failed to respond to a request for a copy of a prescription. There were 32 complaints for 16 patients. Dr. Rockwell stated no requests were received and that the office has a system in place to track faxed requests for information.

Keith Call, attorney for 1-800 Contacts was present to address the Board stating that on November 10, 2016, 1-800 Contacts verified that the fax number is still valid and correct and that Dr. Rockwell has failed to properly respond to a request for a copy of a prescription.

- **MOTION:** Dr. Peller moved to dismiss the case due to lack of violation of the optometric practice act. Dr. Husz seconded the motion.
- **VOTE:** Motion passed 4-1. Dr. Mach voted no. Dr. Lamb recused from the discussion and vote.

Budget:

As of November 30, 2017, 41.67% of the FY elapsed with a beginning cash balance of \$294,613 and an ending cash balance of \$254,659. The significant decrease in the ending fund balance is due to the fund sweep for the eLicensing program and rent for the year. The Board's spending is at 35.06% of the appropriation.

eLicensing Update:

The program is moving along; data has been collected from the agencies and the company who was awarded the contract is working with the agencies to get the system mapped out and coded. The roll-out date is still set for March of 2018.
