## D. INFORMAL INTERVIEW: 9:00 a.m.

This case was continued from the May 19, 2017 meeting at which time the Board moved it to informal interview to further discuss the matter. Dr. Ochiltree was present, without an attorney, to address the Board.

Dr. Chrisagis opened the informal interview and witnesses were sworn in. Dr. Chrisagis asked Ms. Whelan to provide a summary of the case. Ms. Whelan summarized the case as the patient was seen in November of 2013 and was diagnosed with cataracts. The patient had an appointment with a retinal specialist in January 2014 at which time he was diagnosed with a retinal detachment. The patient didn't report any changes in vision to Dr. Ochiltree until several weeks after Dr. Ochiltree saw him, making it challenging to determine when the retinal detachment took place. Dr. Mach stated at the previous meeting that it was possible there was a small tear at the time the patient saw Dr. Ochiltree or it could have happened sometime after the patient was seen by him. The exam records showed the patient had cataracts; there was no documentation of any retinal detachment however, no dilation was performed to determine ocular health when the eye was a 90-diopter lens with cataracts. There was no further treatment recommended by Dr. Ochiltree.

Based on the foregoing summary, Dr. Ochiltree may have failed to properly diagnose and treat a disease of the eye as he did not dilate the patient for proper diagnosis and did not refer the patient to a specialist.

Dr. Chrisagis asked Dr. Ochiltree if he had any response to the summary presented. Dr. Ochiltree responded stating that the summary was grossly accurate. He did refer to patient to a cataract specialist and then referred by that specialist to a retinal specialist. He acknowledged that he did not perform dilation but should have. The patient's blood pressure was elevated at the time which factored in to his decision not to dilate but that perhaps he should have still performed it so he could have better seen the eye to determine what was going on. DR. Mach asked if the patient was taking any hypertension medication at the time of the exam. Dr. Ochiltree stated he was not. Dr. Lamb asked if patient's blood pressure was documented in the record; it was. Dr. Mach asked about the medication used to dilate. Dr. Ochiltree stated he typically used a phenylephrine tropicamide combination. Dr. Mach asked is tropicamide was contraindicative for hypertension. Dr. Ochiltree stated it was not. Dr. Mach asked why he didn't just use that to dilate due to the concern of the hypertension. Dr. Ochiltree stated it was "a fair question" and that he should have considered that.

Closing comments from Dr. Ochiltree: In retrospect, he felt the exam was flawed and was disappointed about the outcome for the patient.

The Board had concern about the lack of referral and how to determine when the retinal detachment took place. It's possible that the tear was not present at the time of the exam but dilation of some kind may have shown symptoms at that time. Dr. Peller felt some form of dilation should have been done, especially due to the patient's high blood pressure as there could have been other things going on in the eye as a result. Dr. Lamb had some concern that Dr. Ochiltree did not refer this patient back to his primary care doctor to address the high blood pressure.

- **FINDINGS OF FACT:** (Allegation #1): Dr. Ochiltree failed to properly diagnose and treat a retinal tear, did not dilate the patient or properly refer the patient to a retinal specialist.
- **CONCLUSIONS OF LAW:** Based on the Findings of Fact, the Board finds violation of A.A.C. R4-21-304 Vision Exam Standards for not performing dilation on the patient on November 8, 2013.
- **MOTION:** Dr. Mach moved to accept the Findings of Fact and Conclusions of Law for Allegation #1; Dr. Ochiltree failed to perform dilation and issue a Letter of Concern for violation of A.A.C. R4-21-304 for failure to follow Vision Examination standards regarding dilation. Dr. Peller seconded the motion.

Dr. Peller summarized case as patient is diabetic and requested records to be sent to a podiatrist for further treatment of a related condition. Patient stated Dr. Vu refused to give her medical records unless she pays for the exam. The records were never sent as requested.

**MOTION:** Dr. Mach moved to issue a Letter of Concern for failure to release records pursuant to A.A.C. R4-21-305(E)(F). Dr. Peller seconded the motion.

3. Matthew Palmer, O.D. IR#2017154

Dr. Mach summarized the case as this was a corneal transplant patient who needed a sclera lens not covered by the insurance however, the fitting would have been covered. The patient left before the exam was completed. Dr. Mach questioned why Dr. Palmer changed the contact lens from gas permeable to scleral when the patient was asymptomatic but saw no violation of the optometric practice act. Mr. Scott King, attorney for Dr. Palmer was present and addressed the Board stating that the patient did leave and in terms of which lens to use, it was a professional call on the part of the doctor as to which lens was best. Dr. Mach noticed in the chart that the patient's acuities were not identified as "with correction" or not.

Dr. Husz felt the Board should subpoena the records and not go to informal interview.

Dr. Mach withdrew his motion to go to informal interview. Dr. Peller withdrew his second to the motion.

**MOTION:** Dr. Lamb moved to subpoen the records of all the patients in Dr. Juarez's practice with the same name who were named in the complaint from 1-800 Contacts. Dr. Mach seconded the motion.

#### Budget:

8.33% of FY elapsed; with a beginning cash balance of \$283,608 and an ending cash balance of \$288,340. The Board is appropriated \$222,200 for FY18. There was a one-time \$10K increase to the appropriation for this FY to cover the cost of the 1-800 Contacts complaints processing and \$2100 for general adjustments. For FY19 budget, there is an annualized cost of \$2231 (related to the move) for armed security in the new building, WiFi, eFax and an FTE to handle the customer service window in the lobby.

### eLicensing Update:

The State is looking at a "standardized" system for licensing for all Boards. There was a committee who reviewed the bids and met with the companies. The bid was awarded and there are 13 Boards who are participating in the initial roll-out, of which the Optometry Board is one. There will be a fund sweep of \$45,900 to pay our portion of the program. It is currently unknown what the ongoing cost will be as the final product is not completed.

### Move Update:

The Board is funding its own move but is trying to have ADOA fund it. The projected move date is January 5, 2018. Our offices will be on the third floor of 1740 W. Adams St. just a few blocks west of our current location.
